### **RESOLUTION # 57 TOWN CLERK TO PLACE A LEGAL NOTICE FOR PUBLIC HEARING FOR FY 2014 PRELIMINARY BUDGET**

On motion by Councilperson Grund, seconded by Councilperson Richardson, the following resolution was the RESOLVED, that the Town Clerk will advertise a Public Hearing for the 2015 Town wide budget to be held on November 5, 2014 at 7:00 p.m. in The Sullivan County Democrat.
